### Revised Notice of Intent (NOI) to be Published in the Federal Register - Thursday, December 22, 2011

The Department of the Navy (Navy) is revising the scope for the EIS for continued and increased training activities on NWSTF Boardman, Oregon. The Navy is modifying its proposed action to including the addition of new Special Use Airspace in the form of a Military Operations Area (MOA). This new MOA would preserve required training capabilities at NWSTF Boardman that are necessary to maintain military readiness.
