# DOJ-OIG FOIA Documents Released 6/18/2010

**June 18, 2010**

On June 18, 2010, as part of the ACLU's DOJ OIG FOIA, the government released a series of FBI emails provided to the DOJ's Office of the Inspector General ("OIG") during an investigation, which culminated in the following report: [\*A Review of the FBI's Involvement in and Observations of Detainee Interrogations in Guantanamo Bay, Afghanistan, and Iraq\*](#). The government also released 268 pages of summaries of interviews conducted by the OIG in preparing the report.
